



Early Childhood Center Enrollment Contract 2018-2019 School Year

The above-named student will be enrolled as a student at The Gordon School, Early Childhood Center (the "School") for the 2018-2019 school year, subject to general statements, rules, conditions, traditions, and financial terms contained in the Gordon School, Early Childhood Center Parent Handbook and Tuition Schedule, along with the following additional conditions and terms:

1) Due Date for Contract and Deposit: A signed copy of this Contract must be delivered to the Beth David Congregation Office and a non-refundable Enrollment Deposit of the Registration Dues & Fees of \$1,510 (members) or \$1,870 (non-members) (the "Deposit") must be paid on or before **January 31, 2018**, in order to assure the student a place in the class/age specified above. The Deposit will be credited as an initial payment in addition to the tuition. If this Agreement is not received by the Beth David Congregation Office and the Deposit is not paid by January 31, 2018, the School will be unable to assure the student a place in the grade specified above. If enrollment is permitted after January 31, 2018, the Deposit must be paid upon enrollment. **THE DEPOSIT IS NOT REFUNDABLE UNDER ANY CIRCUMSTANCES.**

2) Unconditional Obligation to Pay Tuition: Should notice be given that a student is withdrawing from the 2018-19 school year before May 15, 2018, the Deposit will be retained by the School, and there will be no further financial obligation. After May 15, 2018, the School is not required to make any reduction in the full year's tuition and fees as stated in the tuition schedule and the parent is obligated to pay the full tuition whether the student attends the School or not. (Consideration may be granted for families who move out of the area and for emergencies or involuntary withdrawal.) All students are enrolled for the entire year unless it is expressly agreed upon in writing to the contrary.

3) Termination of Enrollment: The School has the right to terminate the enrollment of any student for any reason including, but not limited to, the student's academic performance, the student's conduct, parents conduct, or the student and/or family's inability to abide to the School's policies, rules, regulations, or philosophy. Failure of parents to meet the school's financial obligations is a cause for termination of enrollment.

4) The School is not responsible for damage to or loss of personal property.

5) Should this contract need to be placed in the hands of any attorney and/or collection agency for enforcement, the undersigned agrees to pay all costs of enforcement and/or collection that shall include, but are not limited to, reasonable attorney's fees and costs.
